hereby pre-order a **TWIKE 5** from **TWIKE GmbH, Feldgasse 6, in D-35119 Rosenthal.**

(Technical target data: Start of series production 2023/24, Limited Edition, 500 vehicles numbered consecutively, 3-wheel electric vehicle with optional muscle power assistance, two-seater, registration three-wheeled motor vehicle, EU class L5e, rear-wheel drive, peak power approx. 70 kW, battery voltage 353 V, battery up to approx. 36 kWh, range WLTP approx. 500 km, consumption WLTP approx. 7 kWh, V max up to 190 km/h, base price from approx. 39,900 €, configuration possible after completion of development from approx. Q3/2023).

Alternatively, I do not want to pre-order a TWIKE 5, but a TWIKE 6 (Expected series start 2025, 3-wheel electric vehicle with optional human power assistance, T-Top convertible, two-seater, registered as a three-wheeled motor vehicle, EU class L5e, rear-wheel drive, maximum speed approximately 120 km/h, starting from a base price of approximately €29,900).

Alternatively, I do not wish to pre-order another TWIKE, but I have already made an initial deposit and I am hereby increasing it.

1. For the aforementioned purpose, the preorderer shall make a down payment in the amount of _____ €,

2. The pre-orderer is given preferential opportunity to test drive near-production prototypes before the general public and preferential opportunity for early conversion to an order.

3. The pre-orderer receives a discount when converting his order into a purchase contract, which is based on the amount and the deposit date of his advance payment (the advance payment bears interest at 5% p.a. and the interest shown is granted as a discount when converting it into a purchase contract). The amount of the discount is also used for ranking, which sorts the order of delivery.

4. The pre-orderer is not obliged to convert his pre-order into an order.

5. Early termination is possible. The repayment of the advance payment together with the interest shown to date will then be made with twelve months' notice to the end of the annual quarter to an account of the advance purchaser (please specify when cancelling).

6. Subordination agreement / subordination

a. In order to avoid over-indebtedness of TWIKE GmbH, the preorderer and TWIKE GmbH agree on a comprehensive qualified subordination with regard to all present and future claims arising from this preorder.

b. The subordination has the effect of a resignation behind all creditors who would be creditors pursuant to §38 InsO in the event of the opening of insolvency proceedings against the debtor's assets, as well as a resignation also behind the subordinated creditors within the meaning of § 39 para. 1 InsO. The creditor thereby takes the same rank as any claims for the return of contributions and would have to be satisfied in the insolvency proceedings in the rank of section 199 sentence 2 InsO.

c. From this moment on, the debtor may only satisfy claims of the creditor from future profits and from the assets not required to cover the share capital.

d. The creditor undertakes not to dispose of the above subordinated claims, in particular not to collect them, not to have them secured, not to assign them to third parties, not to pledge them or set them off against them. This does not affect the right to extinguish the claims by withdrawing from the underlying purchase contracts or by waiving them.

7. Should individual provisions of this contract be wholly or partially invalid or become invalid as a result of a change in the law or as a result of supreme court rulings, the remainder of the contract shall remain valid. In such a case, the contracting parties undertake to replace the invalid provision with a valid provision which comes as close as possible to the meaning and purpose of the invalid provision.

8. Amendments to this contract are only possible in writing. This also applies to the amendment of this written form requirement.

9. The place of jurisdiction for all disputes arising from this contract, insofar as this can be permissibly agreed, is Marburg/Lahn.
