Target specifications: Limited Edition, 500 numbered vehicles, three-wheeled electric vehicle with optional human power assistance, two-seater, registration as a three-wheeled motor vehicle, EU class L5e, rear-wheel drive, peak power approx. 70 kW, battery voltage 353 V, battery 20 kWh or 40 kWh, range WLTP approx. 600 km, consumption WLTP approx. 7 kWh/100 km, top speed up to 190 km/h, target base price (20 kWh) approx. €45,200 net up to €48,300 net (40 kWh). Configuration possible after completion of development, with presentation of initial prototypes.

Target specifications: Expected start of series production 15 months after SOP of the TWIKE 5, three-wheeled electric vehicle with optional human power assistance, two-seater, registration as a three-wheeled motor vehicle, EU class L5e, rear-wheel drive, top speed approx. 120 km/h, base price from approx. €25,100 net.

Alternatively, I do not wish to pre-order another TWIKE, but have already made an initial down payment and hereby increase it (**RANK UP**). The higher interest (see 3) and adjusted termination period (see 5) should also apply to the earlier down payments.

2. The pre-ordering party will receive priority access to test drives with near-production prototypes and will be offered early opportunity to convert the pre-order into a binding purchase.

3. Upon converting the pre-order into a purchase contract, a discount will be granted, based on the amount and date of the prepayment (6% annual interest is applied, which is credited as a discount at conversion). The amount of the discount also determines the ranking, which defines the delivery sequence. Overpayments are treated as early cancellations from the day of conversion (see 5).

4. The pre-ordering party is NOT obligated to convert the pre-order into a purchase.

5. Early termination is possible. Repayment of the prepayment plus accrued interest will be made with a 36-month notice period to the end of the respective calendar quarter, to an account specified by the pre-ordering party (please provide when canceling).

## 6. Subordination Agreement

a. In order to avoid over-indebtedness of TWIKE GmbH, the pre-orderer and TWIKE GmbH agree on a comprehensive qualified subordination with regard to all present and future claims arising from this pre-order.

b. The subordination has the effect of a resignation behind all creditors who would be creditors pursuant to § 38 InsO in the event of the opening of insolvency proceedings against the debtor's assets, as well as a resignation also behind the subordinated creditors within the meaning of § 39 para. 1 InsO. The creditor thereby takes the same rank as any claims for the return of contributions and would have to be satisfied in the insolvency proceedings in the rank of section 199 sentence 2 InsO.

c. From this moment on, the debtor may only satisfy claims of the creditor from future profits and from the assets not required to cover the share capital.

d. The creditor undertakes not to dispose of the above subordinated claims, in particular not to collect them, not to have them secured, not to assign them to third parties, not to pledge them or set them off against them. This does not affect the right to extinguish the claims by withdrawing from the underlying purchase contracts or by waiving them.

7. If individual provisions of this contract are or become invalid due to changes in law or court rulings, the rest remains valid. The parties agree to replace invalid provisions with ones that closely reflect their intent.

8. Changes to this contract must be in writing. This also applies to the requirement for written form itself.

9. For all disputes arising from this contract, the place of jurisdiction is Marburg/Lahn, to the extent permitted by law.
